



Preamble:

The Calgary Type A Continuing Care Home (CCH) Formulary identifies the funded drug products for residents residing in Calgary Zone Type A CCHs. The drug products listed on the Formulary will receive full funding when utilized according to Formulary policies, procedures, guidelines and restrictions. Additional funding is available for drug products not listed on the Formulary, or when a drug product is not used according to Formulary guidelines and restrictions through a non-formulary (NF) approval process by Integrated Supportive and Facility Living (ISFL), and where a rational case to support medically necessary use has been presented.

Least Cost Alternative (LCA), alternate strengths, and alternate formulations:

Whenever possible, it is expected that the lowest cost option of a given drug listing be dispensed. Typically, these will be generic medicines or an alternative brand name to the original reference brand product. Similarly, it will be expected to use the lowest cost dosage forms whenever possible and as clinically appropriate (e.g. regular tablets instead of quick-dissolve tablets, or oral solids instead of liquids). Where a drug listed on the Formulary is available in alternate strengths and formulations, funding for the non-listed drug product or strength is not included.

Exemptions to this will only be granted via the NF process on an individual resident basis or in the event of a supply issue, at the discretion of ISFL.

Compounds

Most compounds are non-formulary and must be approved for coverage via the Compound Coverage Criteria process. See **FPP-10** for greater detail.

Grace Period (see FPP-03 for greater detail):

Whenever possible, it is expected that drug regimens be compliant to Formulary listings, restrictions and therapeutic substitutions; however, it is recognized that drug changes to comply with the Formulary at the time of admission are not always feasible, and that time is necessary to collect information and make assessments regarding appropriateness and need. To facilitate admissions and to promote rational prescribing, the committee has built in a "grace period" of up to 3 weeks to allow for medication use that is not in accordance with the Formulary. This grace period applies to most prescription drugs, including those usually considered for auto-substitutions. The grace period allows for short-term funding for drugs not listed in the Formulary and/or used "outside" Formulary guidelines.
